Abstract: Plastic separation from wet organic waste is a very difficult to handle. There are many methods to separate plastic from dry waste. But there are very few methods to separate plastic from wet organic waste. Only possible way is to destroy the plastics, they will burn or dump in ground. As the population of a country increases, the waste produced by them also increases tremendously. There are some of methods for separating the plastic from wet organic waste. Machines which assist these methods are readily available in the market. The major problem with these types of machines is that they need a lot of space and also cost of the machine is high. But this technology requires low cost and occupies a very less space. Simple components and mechanisms are used in this fabrication and an efficient plastic separating machine is built. The main purpose of our study is to design and fabricate cost effective plastic separating machine from wet organic waste. The main aim of the project is to make eco-friendly environment by recycling of waste plastic. First step is to feed waste in to the hopper. In next step waste automatically feed to crusher in which plastic dissect are formed. And by help of belt conveyor we separate plastic from wet organic waste.

The combined solid and liquid waste from residential, commercial, and industrial sources are referred to as municipal wastes and are often perceived as materials generated in urban areas which are unsuitable for further beneficial use, and intended to be discarded, incinerated, recycled in certain ways or considered inherently waste-like (Pankratz, 2001; Cheremisinoff and Graffia, 1995). Solid wastes are more difficult to burn due to the highly variable nature of the waste material in terms of composition and physical characteristics, spanning a wide range of bulk densities and moisture contents, resulting in a wide range heating values (Lee and Lin, 2000). Waste management basically involves the collection, transport, processing, recycling or disposal of waste materials, and is also carried out to recover materials from the waste. The issue of environmental plastic pollution is a global concern (Haward, 2018), with plastic pollution of the marine environment a prominent example of the negative impact of humans on nature (Gall and Thompson, 2015; Law, 2017). In addition to plastic ma-rine pollution, there are also many other negative issues related to plastic consumption, such as land pollution dependence on and de-pletion of non-renewable fossil fuels potential impacts on human and wildlife endocrine systems, and air pollution from inappropri- ate disposal (North and Halden, 2013; Thompson et al., 2009). Given the significance of the problem, the body of literature examining how consumers can be encouraged to reduce plastic consumption is growing (Sharp et al., 2010; Thomas et al., 2016; Wagner, 2017).

a) Container




Fig.1. Containor

A container is any receptacle or enclosure for holding a product used in storage. A containor is shown in fig.1:Container Container is mainly use to store the substance. We use the container to mis the wet organic waste and the water. The wet organic waste is mainly feed with the help of hopper in container. Storage tanks are containers that hold liquids, or mediums used for the short- or long-term storage of heat or cold. In the USA, storage tanks operate under no (or very little) pressure, distinguishing them from pressure vessels. Storage tanks are often cylindrical in shape, perpendicular to the ground with flat bottoms, and a fixed flangible or floating roof. There are usually many environmental regulations applied to the design and operation of storage tanks, often depending on the nature of the fluid contained within. Reservoirs can be covered, in which case they may be called covered or underground storage tanks or reservoirs.

b) Hopper

Hopper as shown in <u>fig.2:Hopper</u> is a large, pyramidal container used in industrial processes to hold particulate matter that has been collected from outside. Hopper is usually large in size to allow for a greater connection. A hopper is a funnel shaped device used to move material from one receptacle to another. We put all wastage into container with the help of hopper. Hopper is directly connected to the container. A container for a loose bulk material such as grain, rock, or rubbish, typically one that tapers downward and is able to discharge its contents at the bottom. In our design hopper is in rectangular shape for more intake. Hopper is directly connected to the container. In hopper we attach the cutting blade.



The cutting blade is mainly used to cut the plastic in small pieces. This cutting blade is run with the help of motor. The cutter blade is place in the hopper. When we put wet organic waste in hopper the plastic is cut by blade and covert into small pieces. Because of cutting the plastic component, these pieces are easily float in the water.

d) Conveyor




Fig.3:onveyor

A conveyor belt is the carrying medium of a belt conveyor system. A belt conveyor system as shown in <u>fig.3: conveyor</u> is one of many types of conveyor systems. A belt conveyor system consists of two or more pulleys. Belt conveyors are the most commonly used powered conveyors because they are the most versatile and the least expensive. Belt conveyors can be used to transport waste in a straight line or through changes in elevation or direction. A small container is attached to the conveyor that is used to collect the plastic from the water. When conveyor run, container is collecting all plastic from the water and throughout from the system.

e) Motors

Mainly motors are use to run the conveyor belt and the cutter blade. An electric motor is an electrical machine that converts electrical energy into mechanical energy. Most electric motors operate through the interaction between the motor's magnetic field and electric current in a wire winding to generate force in the form of rotation of a shaft. Electric motors can be powered by direct current (DC) sources, such as from batteries, motor vehicles or rectifiers, or by alternating current (AC) sources, such as a power grid, inverters or electrical generators. An electric generator is mechanically identical to an electric motor, but operates in the reverse direction, converting mechanical energy into electrical energy. Electric motors may be classified by considerations such as power source type, internal construction, application and type of motion output. In addition to AC versus DC types, motors may be brushed or brushless, may be of various phase (see single-phase, two-phase, or three-phase), and may be either air-cooled or liquid-cooled. General-purpose motors with standard dimensions and characteristics provide convenient mechanical power for industrial use. The largest electric motors are used for ship propulsion, pipeline compression and pumped-storage applications with ratings reaching 100 megawatts. Electric motors are found in industrial fans, blowers and pumps, machine tools, household appliances, power tools and disk drives. Small motors may be found in electric watches. CAD: - Computer-aided design (CAD) is the use of computer systems (or workstations) to aid in the creation, modification, analysis, or optimization of a design. CAD software is used to increase the productivity of the designer, improve the quality of design, improve communications through documentation, and to create a database for manufacturing. CAD output is often in the form of electronic files for print, machining, or other manufacturing operations. The term CADD (for Computer Aided Design and Drafting) is also used.

Its use in designing electronic systems is known as electronic design automation (EDA). In mechanical design it is known as mechanical design automation (MDA) or computer-aided drafting (CAD), which includes the process of creating a technical drawing with the use of computer software.

CAD software for mechanical design uses either vector-based graphics to depict the objects of traditional drafting, or may also produce raster graphics showing the overall appearance of designed objects. However, it involves more than just shapes. As in the manual drafting of technical and engineering drawings, the output of CAD must convey information, such as materials, processes, dimensions, and tolerances, according to application-specific conventions.

CAD may be used to design curves and figures in two-dimensional (2D) space; or curves, surfaces, and solids in three-dimensional (3D) space.

CAD is an important industrial art extensively used in many applications, including automotive, shipbuilding, and aerospace industries, industrial and architectural design, prosthetics, and many more. CAD is also widely used to produce computer animation for special effects in movies, advertising and technical manuals, often called DCC digital content creation. The modern ubiquity and power of computers means that even perfume bottles and shampoo dispensers are designed using techniques unheard of by engineers of the 1960s. Because of its enormous economic importance, CAD has been a major driving force for research in computational geometry, computer graphics (both hardware and software), and discrete differential geometry

The design of geometric models for object shapes, in particular, is occasionally called *computer-aided geometric design (CAGD)*

a) USES:

Computer-aided design is one of the many tools used by engineers and designers and is used in many ways depending on the profession of the user and the type of software in question.

CAD is one part of the whole Digital Product Development (DPD) activity within the Product Lifecycle Management (PLM) processes, and as such is used together with other tools, which are either integrated modules or stand-alone products, such as:

- Computer-aided engineering (CAE) and Finite element analysis (FEA)
- Computer-aided manufacturing (CAM) including instructions to Computer Numerical Control (CNC) machines
- Photorealistic rendering and Motion Simulation.
- Document management and revision control using Product Data Management (PDM).

CAD is also used for the accurate creation of photo simulations that are often required in the preparation of Environmental Impact Reports, in which computer-aided designs of intended buildings are superimposed into photographs of existing environments to represent what that locale will be like, where the proposed facilities are allowed to be built. Potential blockage of view corridors and shadow studies are also frequently analysed through the use of CAD.

CAD has been proven to be useful to engineers as well. Using four properties which are history, features, parameterization, and high-level constraints. The construction history can be used to look back into the model's personal features and work on the single area rather than the whole model. Parameters and constraints can be used to determine the size, shape, and other properties of the different modelling elements. The features in the CAD system can be used for the variety of tools for measurement such as tensile strength, yield strength, electrical or electromagnetic properties. Also, its stress, strain, timing or how the element gets affected in certain temperatures, etc.

TYPES:

There are several different types of CAD, each requiring the operator to think differently about how to use them and design their virtual components in a different manner for each.

There are many producers of the lower-end 2D systems, including a number of free and open-source programs. These provide an approach to the drawing process without all the fuss over scale and placement on the drawing sheet that accompanied hand drafting since these can be adjusted as required during the creation of the final draft.

3D wireframe is basically an extension of 2D drafting (not often used today). Each line has to be manually inserted into the drawing. The final product has no mass properties associated with it and cannot have features directly added to it, such as holes. The operator approaches these in a similar fashion to the 2D systems, although many 3D systems allow using the wireframe model to make the final engineering drawing views.


3D "dumb" solids are created in a way analogous to manipulations of real-world objects (not often used today). Basic three-dimensional geometric forms (prisms, cylinders, spheres, and so on) have solid volumes added or subtracted from them as if assembling or cutting real-world objects. Two-dimensional projected views can easily be generated from the models. Basic 3D solids don't usually include tools to easily allow motion of components, set limits to their motion, or identify interference between components.

There are two types of 3D Solid Modelling


- Parametric modelling allows the operator to use what is referred to as "design intent". The objects and features created are modifiable. Any future modifications can be made by changing how the original part was created. If a feature was intended to be located from the centre of the part, the operator should locate it from the centre of the model. The feature could be located using any geometric object already available in the part, but this random placement would defeat the design intent. If the operator designs the part as it functions the parametric modeler is able to make changes to the part while maintaining geometric and functional relationships.
- <u>Direct or Explicit modeling</u> provide the ability to edit geometry without a history tree. With direct modelling, once a sketch is used to create geometry the sketch is incorporated into the new geometry and the designer just modifies the geometry without needing the original sketch. As with parametric modelling, <u>direct modelling</u> has the ability to include relationships between selected geometry (e.g., tangency, concentricity).

Top end systems offer the capabilities to incorporate more organic, aesthetics and ergonomic features into designs. <u>Freeform surface modelling</u> is often combined with solids to allow the designer to create products that fit the human form and visual requirements as well as they interface with the machine.

2. WORKING METHODOLOGY

In this system our aim is to remove the plastic parts from the wet waste. Firstly a wet form of waste is inserted into the tank. Then water is allowed to be inserted into the same tank. At the upper side a conveyor is used which removes the plastic, so accordingly water level is maintained. The working principle of the system is based on the density difference. As the density of plastic is low due to the addition of the water it starts floating on the water surface. This floating plastic is then collected with the help of conveyor mechanism. A motor is used to drive this belt and finally the plastic is collected at the other bottom side.

BASIC DESIGN CALCULATIONS FOR PLASTIC SEPERATOR MACHINE-

Given:

Belt and roller material=Rubber and plastic

Density of high density polypropylene plastic=970 Kg/m3

Density of the belt material (Qrubber)=1522kg/m³

As the density of rubber is much higher than the plastic material, we have to consider the maximum density to calculate the mass of conveyor belt. Hence here we are considering the density of the rubber material.

Thickness of belt (t)=5mm=0.005m

Diameter of roller (Φ)=50 mm=0.05m

Width of belt=Width of roller=(b)=0.450 m

Length of conveyor (1)=0.450 m

Now length of the conveyor belt is calculated as,

Length of belt=(2*length of conveyor)+[2*(1/2* circumference of roller circle)]

Length of belt =1.57=1.6 m

Mass of belt is calculated as,

So accordingly we can select 12v & 5A battery which generate 60s watt power

Design of Motor attached to cutting mechanism (Hopper)-

Now to cut the waste with plastic we require 200 N force, and the diameter of shaft be 10 mm.

So, required torque is given as(T)=F*R

=200*0.005

T=1 N-m-----B

As A>B our design is safe.

a) Shaft Design-

In our design the power supplying motor is directly connected to the roller, and the roller is considered as shaft. Now at the starting point of calculation to calculate the total weight of belt and conveyor system, we have taken the diameter of roller(shaft) as 50mm. So, for the safe design the calculated shaft design diameter must be less than the considered value of the shaft diameter.

From Design Data Book -V.B.Bhandari- Page no-9.4, we can find out the outer diameter of the shaft.

As we are using 60 Watt power motor, with constant 10 rpm rotations, We can find out the required torque value as,

P=(2*3.14*N*T)/(60)

T=57.29 N-m.

This torque(T)=Mt=Torsional moment torque acting on shaft.

Hence.

L=Length of the shaft=450mm.

G=Modulus of rigidity=79300 N/mm²(For steel shafts)

e=Angle of twist= 3 degree per meter length for line shafts.

Diameter of the shaft(D)=2.82 mm.

So, as our calculated shaft diameter value is much less than the considered value for same amount of power and torque transmission, our design is safe.

b) Design of bearing-

From design data book V.B.Bhandari-Page no-15.7 we can select bearing for the shaft diameter of 10 mm.

Here we select single row deep groove ball bearing designated as-6200(SKF)

Dimensions, load capacities of bearings is given as,

Inner Diameter of bearing=10mm

Outer diameter of bearing=30mm

Width of bearing=9 mm

Basic load ratings(C)=5070 N and (C₀)=2240 N
