GLOF functions have triggered the important harm to both men's lives as well as infrastructure, especially in mountainous areas of the Himalayas in the Nepal as well as the northern area of the Bangladesh. Grameen Shakti additionally offers work to individuals in their network to produce accessories for solar household methods.² Over 1,000

Through its Small Grants Programme (SGP),³ the GEF emphasizes the benefits of gender main-streaming within its programming, although this might differ by the project. The GEF states, "While the degree of relevance of gender dimensions may vary depending on the GEF focal area or type of engagement, accounting for gender equity and equality is an important consideration when financing projects that address global environmental issues, because gender relations, roles responsibilities exercise important influence on women and men's access to and control over environmental resources and the goods and services they provide."²
