- **Step 3:** is a 3D visualisation of the structure. In order to obtain a three-dimensional perspective of the construction, we have applied the Transitional repeat command in the Y direction here.

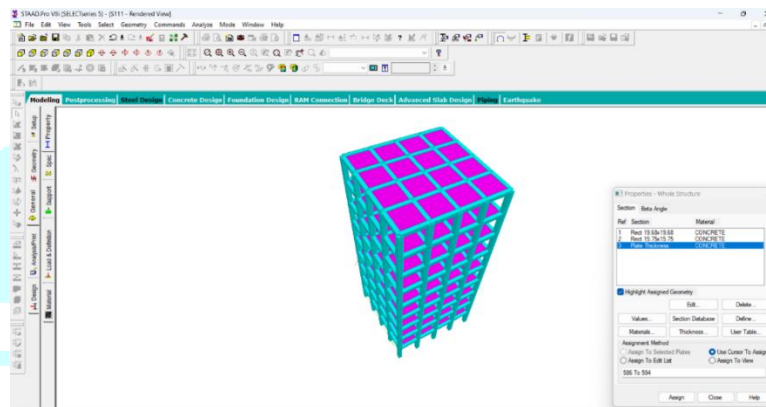


Figure 1: 3D visualisation

In addition, the materials were designated, and the cross sections of the beams, columns, and members were decided upon.

- **Step 6:** involves the distribution of wind loads. In accordance with IS 875 PART 3, wind loads are established on the basis of the computed intensity and the exposure factor. After that, loads are added in the load case details in the +Z,-Z, and +X -X directions respectively.

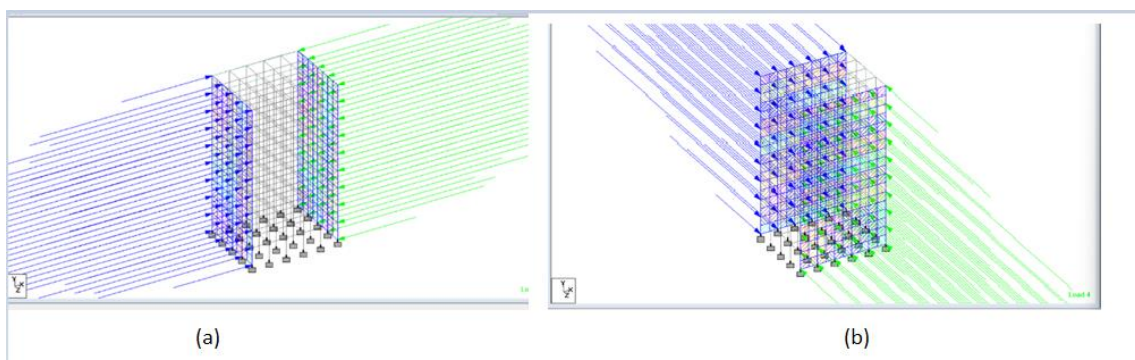


Figure 2: (a) wind loads in X direction (b) wind loads in Z direction

- **Step - 10:** Analysis Following the completion of all of the Steps that came before it, we carried out the analysis and checked for mistakes.
- **Step - 11:** Design. Last but not least, the design of concrete is carried out in accordance with IS 456: 2000 by specifying appropriate design directives for various structural components. After we had finished assigning commands a second time, we did an analysis to check for problems.

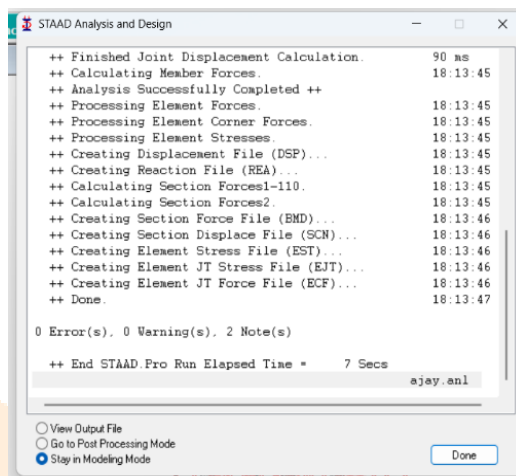


Figure 3: STAAD. Pro Pre processing

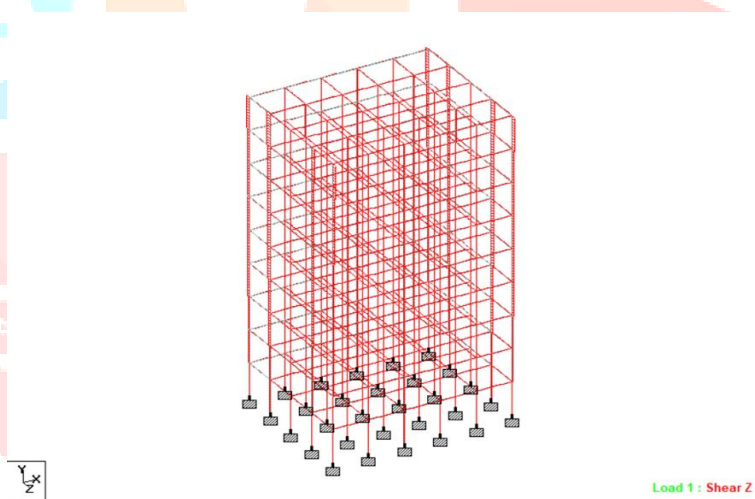


Figure 4: Shear force in Z direction due to dead load

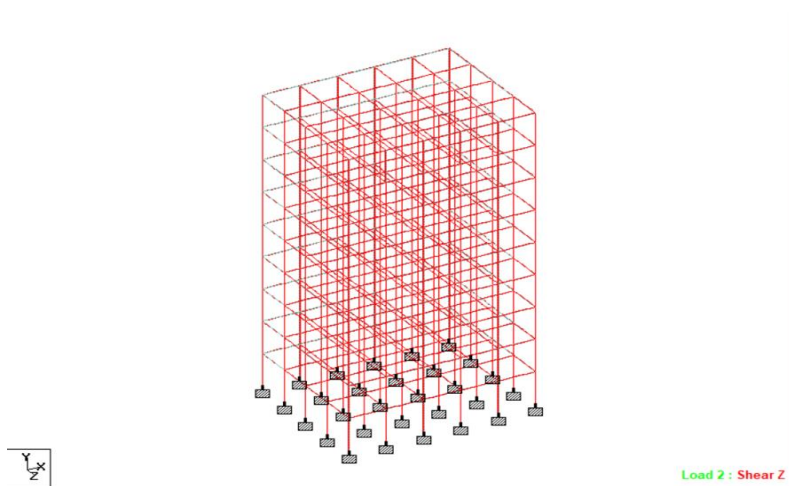


Figure 5: Shear force in Z direction due to Live load

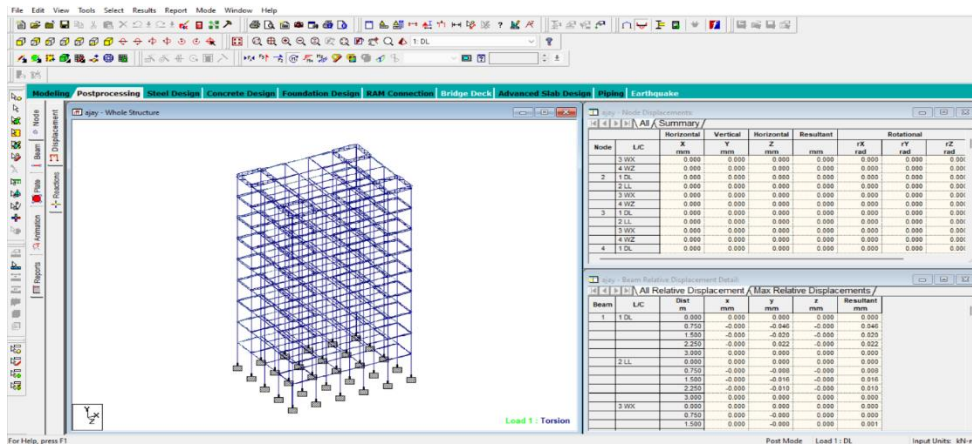


Figure 6: Torsion due to dead load

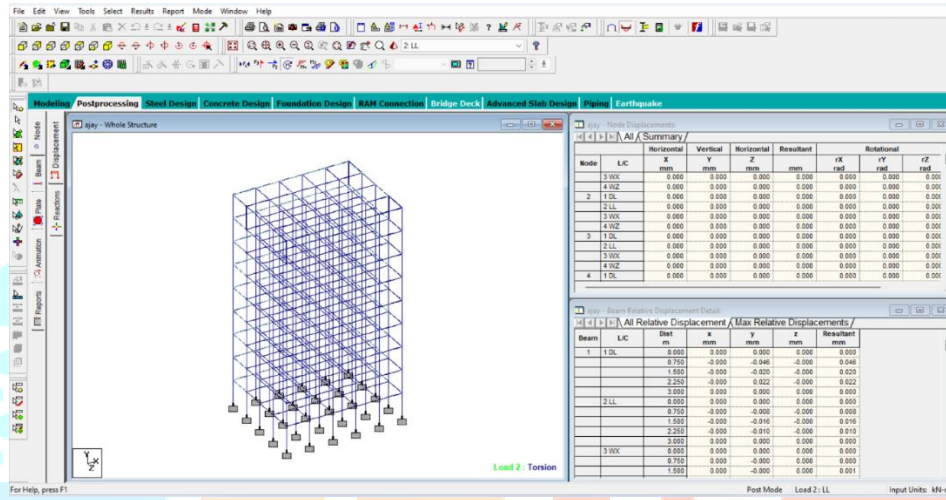


Figure 7: Torsion due to Live load

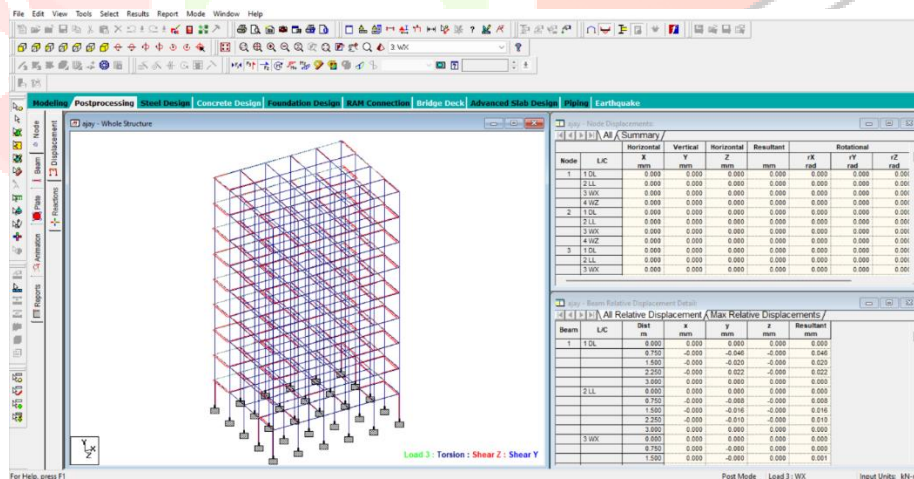


Figure 8: Torsion, shear force in Z and Y direction due to wind load in X direction

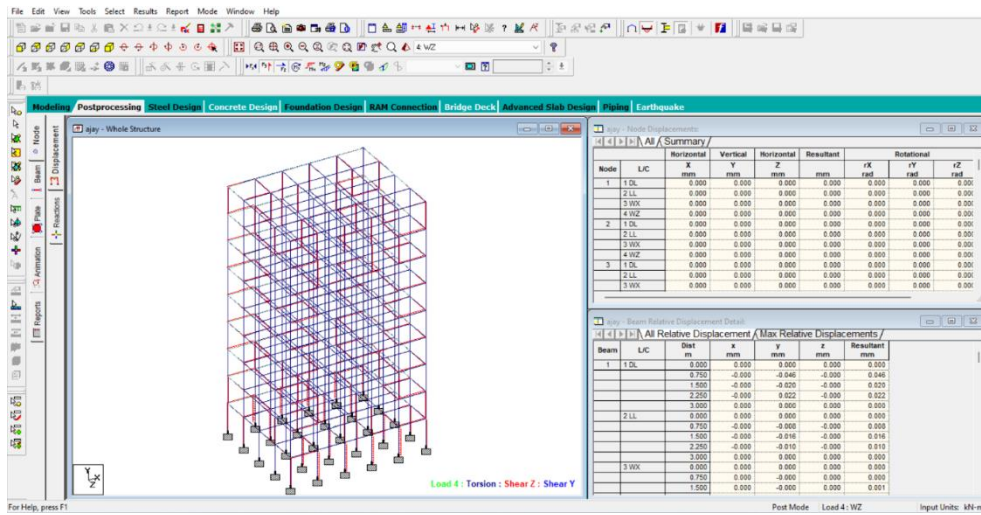


Figure 9: Torsion, shear force in Z and Y direction due to wind load in Z direction

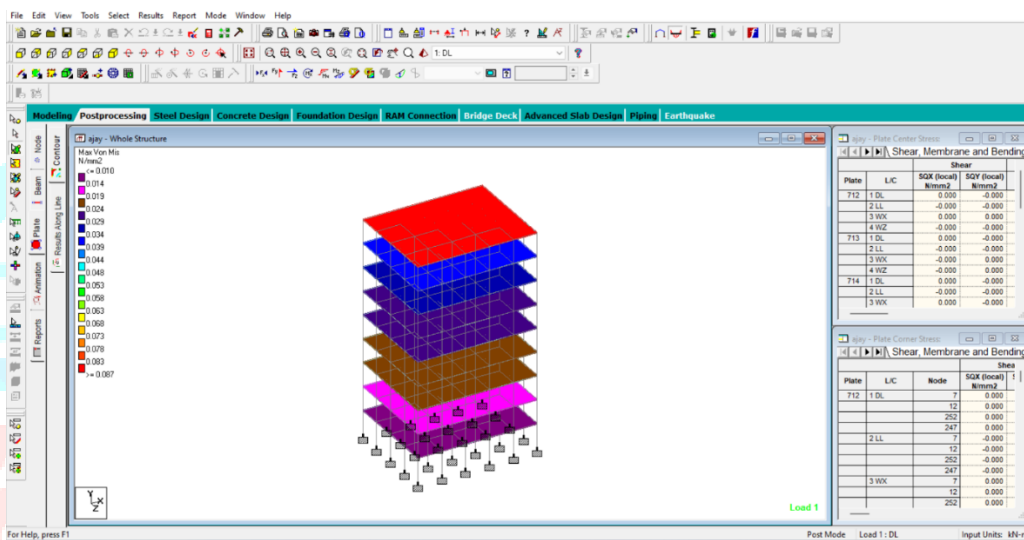


Figure 10: Max Von Miss

- Horizontal Z (Displacement): Represents the displacement in the Z-direction (vertical) for each node. The values indicate the magnitude of displacement measured in millimeters.
- Resultant (Displacement): Represents the overall or resultant displacement for each node, combining the displacements in all three directions (X, Y, Z). The values indicate the magnitude of displacement measured in millimeters.

Interpreting the values in the table:

- Max X: Node 59 experienced the maximum displacement in the X-direction, with a magnitude of 0.015 mm under load case 1 DL.
- Min X: Node 56 experienced the minimum displacement in the X-direction, with a magnitude of -0.015 mm under load case 1 DL.
- Max Y: Node 178 experienced the maximum displacement in the Y-direction, indicating no displacement (0 mm) under load case 4 WZ.
- Min Y: Node 55 experienced the minimum displacement in the Y-direction, with a magnitude of -3.314 mm under load case 1 DL.
- Max Z: Node 240 experienced the maximum displacement in the Z-direction, with a magnitude of 0.014 mm under load case 1 DL.
- Min Z: Node 120 experienced the minimum displacement in the Z-direction, with a magnitude of -0.014 mm under load case 1 DL.
- Max Rst: Node 55 experienced the maximum resultant displacement, with a magnitude of 3.314 mm under load case 1 DL.

These displacement values provide insight into the structural behaviour of the G8 building under the specified load cases. The displacements can help assess the building's stability, structural integrity, and potential areas of concern that may require further analysis or corrective measures.
