Introduction

The "Economic Survey 2022-23, Jammu and Kashmir Government, reviews the developments in the J&K GSDP is likely to be doubled in the next five years with an emphasis on the service sector, industries, agriculture, horticulture, and tourism. J&K is developing 75 new tourist destinations, 75 heritage/cultural sites, 75 sufism/religious sites & 75 adventure treks/sites attracting potential for all four seasons in the areas of nature, adventure, pilgrimage, heritage, sports, etc. More areas of tourism like amusement, water parks, adventure (water sports, Rafting, Rock climbing, Snow parks), etc and entertainment are being explored to attract more tourists. Tourism, Agriculture, Horticulture, and Power clubbed with Improved Infrastructure, Connectivity, Logistics, better Health and Education facilities, Digital Governance and effective Grievance Redressal Mechanisms shall be the core areas for realizing Vision 2047.

Jammu & Kashmir is an important tourist destination and has been a place of attraction for tourists for centuries. The lush green forests, sweet springs, perennial rivers, picturesque alpine scenery, and pleasant climate of Kashmir valley, have remained an internationally acclaimed tourist destination, whereas Jammu region- the land of temples is attracting a large number of pilgrim tourists and the important destination has been Shri Mata Vaishno Devi Shrine. The diversity of its habitats is equaled by the remarkable variety of flora and fauna. Its unique tourist places like Dal Lake, Pancheri, Gulmarg, Pahalgam, Sanasar, Mansar, Doodhpathri, Yousmarg, Achabal, Bagh-e-Bahu, Mantalai, etc. have attained international recognition and these natural assets make J&K a paradise on the earth. The climate favors all seasons, therefore well known as "A destination for all seasons" which has placed UT of J&K in the limelight at the national level as well as at the international level.

The tourism sector is the main driver of the economy of UT of Jammu & Kashmir. This sector has given jobs to a large number of people and generated economic activities, especially in the tertiary sectors. Its impact is visible in services and industry sectors such as transport, hospitality, horticulture, and small-scale industry. The more the arrival, the more economic activities get generated and make an impact on the related sectors accordingly. Tourist expenditure generates multiple effects on sectors like agriculture, horticulture, poultry, and handicrafts. The positive economic effects of tourism can be understood through the generation of national income, the generation of foreign exchange, the raising of tax revenue, the expansion of employment opportunities, and the transformation of the regional economy. The government of J&K has constructed/developed various tourism-related infrastructures at different tourist spots/destinations to boost the tourism sector and to provide better facilities to intending tourists/ visitors. The infrastructure created will increase the tourist inflow and has the potential to increase per-visitor spending and length of stay in the UT.

The developments of destinations have prompted significant tourist inflow in J&K. Continuous efforts are being made through print & electronic media to promote J&K as an ideal tourist destination.

J&K Tourism Policy was formulated in the year 2020 which is a holistic framework for sustainable and responsible growth of the tourism sector and aims at improving the conditions for tourism development, supporting tourism industries, strengthening tourism-support functions, and developing tourism sub-sectors. The policy has been prepared with the objective of positioning tourism as a major engine of economic growth and harnessing its direct and multiplier effects for employment and poverty eradication in an environmentally sustainable manner. The Policy aims to generate employment for approximately 50 thousand people per year. Moreover, as per Tourism Policy 2020, there is an expectation to attract an average investment target of Rs. 2000 Crore per year for the next 5 years. The Department lays a sharp focus on developing/exploring the potential for emerging markets through targeted marketing strategies and ensuring simplification of procedures for registration and renewal of tourist units by adopting a single window clearance mechanism for ease of doing business. In addition to this, strong and sustainable private-sector participation is encouraged in the creation of Tourism Infrastructure especially through Public-Private Partnership (PPP mode).

The highest-ever arrival of tourists to Kashmir during 2022 was about 27 lakhs as compared to the previous highest of 13 lakhs in 2016. The government focuses on meeting the accommodation needs of the tourists/visitors, J&K has a total room capacity of 58,100 with a bed capacity of 1,24,196 (including government and private sector). Homestays are being encouraged and tented accommodations are being developed to add to the person's capacity.

Tourism Department endeavours to make tourism in UT of J&K an enriching experience for the tourists, increase livelihood opportunities of the people of J&K, and also position itself as a leading global destination by the year 2025 by making it a destination that is natural in its environs, global in standards, modern in outlook, traditional in hospitality, mystical in sensibilities and entertaining in experience. Among other things, The department aims at achieving the following main objectives:

- Enhancing J&K's brand image by using sustained and effective marketing with a special focus on information technology intervention and standardizing the establishment of tourism products and services by way of the establishment and installation of eco-friendly infrastructure.
- Developing potential emerging markets through targeted marketing strategies and enhancing the economic prosperity of Jammu and Kashmir.
- Simplification of procedure of registration and renewal of tourist units through Single Window Clearance mechanism for Ease of Doing Business Besides encouraging strong and sustainable private sector participation in the creation of tourism infrastructure especially Public Private Partnership (PPP).
- To harness the opportunities available in the sectors like Adventure Tourism, Caravan Tourism, Helicopter Tourism, Eco-Tourism, Pilgrimage Tourism, Rural Tourism, Wellness Tourism, Agro Tourism, MICE Tourism, Heritage Tourism, and Golf Tourism.
- Promote effective inter-departmental cooperation to streamline processes and increase sector performance in areas like Horticulture Agriculture, Apiculture, Sericulture, Handicrafts, etc.
- Promote sustainable tourism and encourage the conservation and preservation of unique nature and cultural heritage of J&K and upgrade highways and wayside amenities and facilities leading to tourist destinations including the development and promotion of off-beat destinations.

The following roadmap has been drawn to achieve the objectives/vision of the tourism sector, Development of Tourism infrastructure, Development of Lakes and Wetlands, New Tourist Circuits and Seasonal Tourism, Development/promotion of off-beat destinations, Improved accessibility to the destinations, and Marketing/promotional tools, Human Resources Development and Capacity Enhancement, Sustainable Tourism and Carrying Capacity, Public Private Partnership for development of tourism infrastructure and Safety and Security Management etc.¹

According to the Jammu and Kashmir Tourism Department, the region witnessed a surge in domestic and international tourist arrivals in recent years. Jammu & Kashmir records 1.89 crore tourist arrivals up to December 2022, the highest in 75 Years. The tourism industry in the state of Jammu and Kashmir generates around Rs. 8,000 crores annually, contributing to nearly 7% of the state's GDP. Despite intermittent political unrest, tourism has been flourishing in the valley due to the beautiful and serene landscapes and rich cultural heritage that it offers. The tourism industry has the potential to uplift the local economy of Kashmir and create job opportunities for the residents. However, there are a few challenges that the sector needs to address to realize its full potential. For instance, the lack of basic infrastructure facilities like roads, electricity, and connectivity in certain areas which are essential for the smooth operation of tourism businesses. To overcome these challenges, the state government and stakeholders must think beyond the conventional approaches and focus on developing sustainable tourism practices. For example, focusing on eco-tourism, adventure tourism, and cultural tourism can help diversify the tourist footfall throughout the year, generating revenue, and offering employment opportunities at the grassroots level. Moreover, promoting international tourist arrivals through aggressive marketing and branding of the region can help to create a global brand image of Kashmir as the preferred tourist destination, which can pave the way for large-scale investments in the sector.²

Against 4028 foreign guests in 2022, in the first eight months of this year 30647 arrivals have been recorded, an official of the Tourism Department said. Most of the foreign tourists who visited Kashmir this year were from Europe, Thailand, Malaysia, and the Middle East. "Apart from the domestic travel fairs, we are going to participate in international travel trade marts to promote Kashmir tourism. Moreover, 75 new offbeat destinations are also coming up primarily to attract foreign tourists," he said. President of Travel Agents Association of Kashmir (TAAK) Farooq Ahmad Kuthoo said post the G20 summit, a strong message went to foreign countries that Kashmir is safe for tourists. "Right now, travel agents are also individually in touch

with foreign associations From trekking to greater lakes to heritage tours, travel agents have framed special packages for foreign tourists. The Third Tourism Working Group (TWG) G20 meeting, held from May 22-24, was one of the biggest international events organized in Jammu & Kashmir after the abrogation of the erstwhile state's special status under Article 370 in August 2019. At the 3rd G20 TWG meeting, the Ministry of Tourism and the J&K administration pushed for the revival of not only tourism but also filmmaking in the Valley. Kashmir was one of the favorite destinations of foreign tourists in the 1960s, 1970s, and 1980s. With the start of the insurgency, the numbers fell drastically. And now with peace returning to the Valley, the foreign tourists are yet again flocking to the 'Paradise on Earth.'³

New destinations/areas are being promoted by way of infrastructure facilities to bring them on the tourism map of the UT. The tourism department Under Swadesh Darshan 2.0, the UT's Perspective Plan for the below-mentioned circuits has been prepared and submitted to the Ministry of Tourism (MOT), GOI:-

- Bhaderwah Adventure/Eco Tourism
- Wullar Water Adventure
- Surinsar Lake tourism
- Doodhpathri Eco tourism
- Basholi Adventure Tourism

To promote spiritual tourism the GoI under the "Prasad" Scheme has sanctioned Projects for the Development of Hazratbal Shrine and a project for the Development of a Tourist facility at Shri Mata Vaishno Devi Ji Katra has been also formulated for projection to MOT, GoI for approval. For optimum utilization of assets &

employing unemployed youths the assets created by the department are being outsourced to private players for Operations & Maintenance. To lessen the burden on the most frequently visited destinations the Government has identified 75 Off-beat tourist destinations thereby reducing the carbon footprint at frequently visited destinations. Similarly, new trekking routes have been identified and are being promoted. To promote pilgrim tourism, new pilgrim / sufi circuits are being identified and promoted to connect famous shrines like Shri Mata Vaishno Devi, Shri Amarnath Shrine, Hazratbal, Charar-e-Sharief with the hitherto lesser-known pilgrim places.⁵

It is crucial to strike a balance between promoting tourism and preserving Kashmir's fragile ecosystem and cultural authenticity. Sustainable tourism practices and responsible travel are keys to ensuring the region's long-term viability as a major tourist destination. Commercialized tourism would lead to problems such as the region's environmental and cultural degradation, overcrowding, and socioeconomic disparities.⁶

There is vast potential for the development of community-based tourism as a form of alternative tourism in Jammu and Kashmir. If properly developed, community tourism could bring great benefits to the valley. It could be a sustainable revenue-generating project for the rural development of the government. It can help the inflow of resources from the urban to the rural economy. It can prevent the migration of rural people to urban areas which are crowded. Both short-term and long-term planning, implementation, and monitoring are vital in avoiding damage to rural areas. Environmental management, local involvement, sound legislation, sustainable marketing, and realistic planning are crucial for the development of rural tourism. Community-based tourism will emerge as an important instrument for sustainable human development including poverty alleviation, employment generation, environmental regeneration and development of remote areas, and advancement of women and other disadvantaged groups in the region apart from promoting social integration and international understanding.⁷ Moreover, the focus should be on promoting eco-friendly tourism practices, conserving natural resources, preserving local culture and heritage, and ensuring equitable distribution of the benefits of economic development. With these measures, Kashmir can become a shining example of economic and social development, and a source of pride for its residents. It's important to note that the pandemic had a significant impact on the tourism industry in J&K, but the sector is now on a strong recovery path. The future of J&K tourism looks promising, with the potential to generate significant revenue and create jobs for the local population.⁸
