usually via the use of force, compulsion, or abuse of authority. Rape is defined under Section 375 of the Indian Penal Code (IPC). Section 376 of the IPC outlines the punishment for rape and specifies several sanctions according to the seriousness and specifics of the offense. The Latin verb "rapere" (meaning "to snatch, to grab, to carry off") is where the word "rape" comes from. According to Roman law, "raptus" refers to the forcible removal of a woman, whether or not sexual relations are involved. In medieval English law, the word "sexual violation" might be used to describe either rape or kidnapping.

Three essential components make up the legal definition of rape: non-consensual sexual contact, the use of force or compulsion, and the abuse of authority. Most countries define rape as sexual contact or other sexual penetration when a perpetrator engages in sexual activity with a victim without the victim's permission. Governmental health agencies, law enforcement, medical professionals, and the legal profession all have different definitions of what constitutes rape Rape can take many forms, including statutory rape, acquaintance rape, date rape, marital rape, and stranger rape. Rape by an unknown individual is referred to as stranger rape. Rape perpetrated by a person the victim knows, such as a friend, relative, or romantic partner, is referred to as acquaintance rape. Date rape is defined as rape perpetrated by a person the victim is romantically involved with or dating. Marital rape is defined as rape that takes place within a marriage or intimate relationship and is perpetrated by a spouse or partner. Statutory rape, on the other hand, is defined as rape against a minor, even if the juvenile gives consent for the sexual activity.

How often the crime is in a certain community or area is known as the prevalence of rape. It is difficult to determine the prevalence because of shame, underreporting, and varying legal and cultural definitions of rape. The World Health Organization (WHO) estimates that one in three women worldwide may at some point in their lives be the victim of physical or sexual assault, with rape accounting for a sizable fraction of these incidents. Although men and boys are also impacted, particularly in specific settings like prisons or times of conflict, women and girls are the most frequently raped Detailed crime statistics give some indication of prevalence in many wealthy countries. According to the United States' rape case statistics, approximately 376,038 women and 104,979 men were raped or sexually assaulted in 2023. The United States had 38 forcible rapes for per 100,000 individuals in 2023. Compared to 1990, when the rate was 41.2 per 100,000, this represents a minor decline.

Although it is on the decline, Australia's recorded rape rate per 100,000 is still extremely high, having dropped from 91.6 in 2003 to 28.6 in 2010. An estimated 51,200 (0.3%) Australians who were 18 years of age or older experienced sexual **assault in 2011–12.** Nearly one-third (30%) of sexual assault victims reported their most recent experience to the police. The US Department of State reports that 31,833 rape incidents occurred in China in 2007. Twelve percent of women in Europe have been the victims of rape or attempted rape. 18.3% of women in North America have been the victims of rape or attempted rape. In South Africa, 45% of women report having been the victim of sexual violence, including rape.

The National Crime Record Bureau reports that 31,677 rapes—or around 87 rapes every day—were reported in India in 2020. In 2020, there were 5.7 recorded rapes for every 100,000 people in India. In 2020, India's rape

conviction rate was approximately 27.2%. In 2020, minors, or those under the age of 18, accounted for 43.4% of all reported rape victims. In Delhi, 94.9% of rape incidents that were reported included a perpetrator the victim knew. In India, rape is frequently underreported because of things like embarrassment, fear, and a lack of faith in the government. It might be difficult to identify trends and patterns in India's rape data because of its variable completeness and accuracy.

Rape can have a serious and enduring effect on a person, impacting many facets of their life. The effects of rape can be classified as either psychological or physical. Vaginal or genital bleeding or infection, hypoactive sexual drive disorder, vaginal inflammation, dyspareunia, a painful sexual experience, chronic pelvic pain, urinary tract infections, pregnancy, and sexually transmitted diseases like HIV/AIDS are among the frequent physical effects of rape. Rape-related pregnancy is a delicate and complicated topic. Pregnancy occurs in 1% to 5% of rapes. Every year, about 32,000 pregnancies in the US are the result of rape. The survivor's possible unwillingness to seek prenatal treatment may increase the health concerns associated with rape pregnancies. The first few days following an assault are the most psychologically taxing for the majority of rape survivors. Many survivors, though, can suffer from chronic psychological damage. Rape frequently has the following psychological effects: Post-traumatic stress disorder (PTSD), which manifests as anxiety, nightmares, and flashbacks, can strike rape survivors. Rape survivors frequently experience depression, despair, and hopelessness. Long after the attack, people may continue to experience fear, worry, and hypervigilance. Survivors could have feelings of guilt, shame, or responsibility for the attack. Rape can result in low self-esteem, self-blame, and a negative self-image.

The survey has been conducted for a span of 10 days.

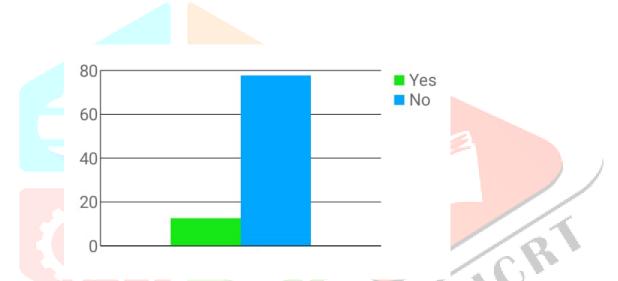
4. METHOD USED:

RESULT:

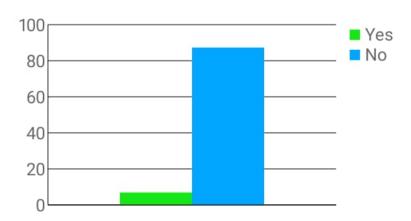

1. People who have experienced sexual abuse are among the samples that are being examined using my survey.



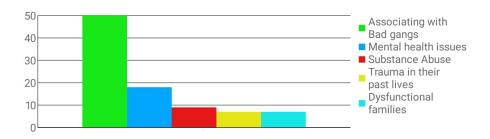
(fig:1 Graph depicting the people who are suffered from sexual abuse)

2. People who are threatened with sexual abuse on social media are among the samples that are being examined by my survey.

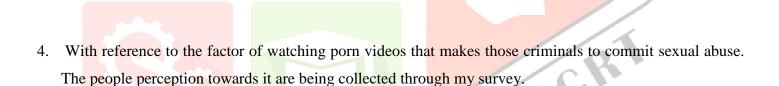


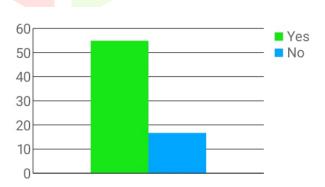
(fig:2 Graph depicting the people who are threatened sexual abuse through social media)

(fig:3 Graph depicting the factors of committing sexual abuse)

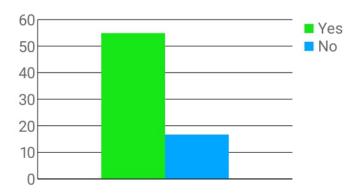




(Fig: 4 Graph depicting watching porn videos makes them to commit crime)

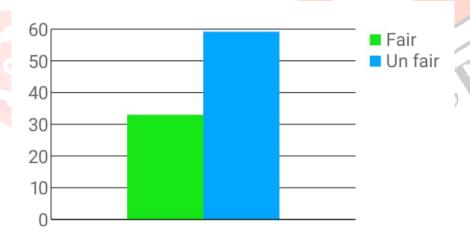

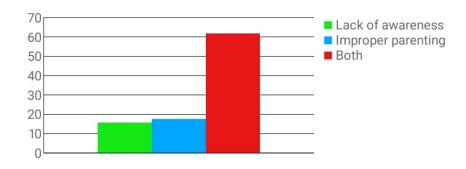
(Fig:5 Graph depicting people are more of sexual abuse)

6. With reference to the survey, Maximum people's perception is that the punishment given by the Indian law to the sexual abuse is unfair



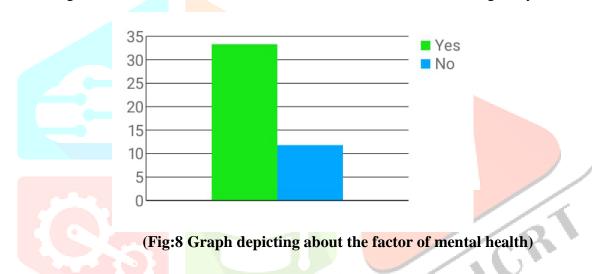
(Fig:6 Graph depicting people's perception of Indian law 's punishment to the sexual abusers)

7. With reference to the survey, the factor of committing sexual abuse in children is being analysed

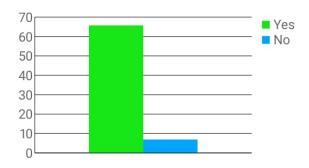


(Fig:7 Graph depicting the factors of committing sexual abuse in children

DISCUSSION:

With concerning rates of child sexual abuse documented in recent years, sexual abuse is still a major worry in India. A 2023 report found that the amount of child sexual abuse content on social media in India has increased by 250–300%. Approximately 12.6% of people have experienced sexual abuse in their lives, while 77.7% have not. According to my survey, conducted using Google forms, 50% of respondents believe that being a member of a bad gang causes people to commit sexual abuse, and 18% believe that a criminal's mental health issues cause them to commit sexual abuse. It is evident that 54.9% of respondents believe that watching porn videos causes those criminals to commit rape and sexual abuse. About 61.8% of respondents believe that inadequate parenting and ignorance are major factors in child sexual abuse, while 33.8% believe that criminals' mental health issues lead them to commit sexual abuse, and 65.7% believe that drug or substance abuse leads those criminals to commit sexual abuse. 70.9% of individuals are aware of sexual abuse and the implications of the victim's lives. 59.2% of the people claims that the punishment offered by the Indian legislation to the sexual abusers and rapists are unfair and 33% of the people thinks that it is fair. The report emphasizes the importance of raising awareness and educating people about the many variables that contribute to sexual abuse. Addressing mental health concerns should be a top priority since they should be seen as a major contributing factor to sexual abuse. More research should be done on the possible behavioral effects of substance addiction and pornography. The idea that sexual abuse punishment is unjust raises the possibility that laws need to be reviewed and updated to make sure they are successful in stopping and dealing with sexual abuse.

The survey's findings point to a big chance for sexual abuse education and awareness, which can help people comprehend this complicated problem.
