The urge of peace education is one of the fundamental agenda of 21st century to protect the actual state of human existence; the environment is also facing continuously a lot of difficulties. Through the effective study of peace education, effective knowledge regarding negative influence of violence/conflicts and positive influence of non-violence, effective skills to control the tendency of violence and aspiration of conflicts, effective skills to nurture the principles and strategies of non-violence, effective attitudinal pattern regarding to assess and to evaluate the basic characteristics of violence and different corresponding aspects, effective attitudinal pattern to follow an effective pattern of ideal style to maintain the principles/policies of non-violence for the benefit of human society, effective valuing system regarding the approach to maintain effective social eco-system for the benefit of universal existence, will be inculcated within the society that will help to nurture an effective integrated personality pattern for humanity. Peace education helps to design any situation in favour of the human interest and to create some favourable conditions to make an effective resistance against the non-desirable conflicts. To reduce the harmful impacts of social conflicts, it is an effective approach to regulate the corresponding system in an effective manner. There are so many forms of conflicts against the actual pattern of human existence namely intrapersonal conflicts, interpersonal conflicts, intergroup conflicts, national conflicts, and international conflicts etc. All types of conflicts are non-desirable against the actual exploration of humanity for the benefit of society. In the base to build an effective nation to maintain the principles of nationality, peace for nation is more fundamental to regulate norms of national development. Execution of the principles of peace education in all over the world, the ideology of international understanding as well as international integration will be regulated for the effective humanity of the universe. The universal tolerance is an effective indicator of international peace and humanity; this approach of tolerance is desirable in respect to build one nation for assure the ideology of *oneness*. 4.0. Analysis of Code:

Peace education is an important agenda of modern society. It also has been considered as a quality indicator of basic education system. To fulfill those objectives of basic education, a society will be able to develop a society having the principles of universal tolerance, universal brotherhood. To analyse the corresponding code related to the peace education as well as social sustainability have been presented below.

4.1. Analysis of Code on Peace Education:

Three fundamental codes namely knowledge code, skill code and attitude code attached with the basic pattern of peace education which are analyzed below on the basis of different logical considerations. Corresponding codes have been analyzed in following manner.

In the study of peace education, a strategic study of conflict analysis will provide circumstances regarding the nature of conflicts and also a number of effective solutions of conflicts. Through the proper exercises of conflict, an individual will be able to find out a lot of approaches of conflict resolutions. Therefore, the study of peace education is more significantly important for the benefit of society with the help of effective development appropriate concept regarding different approaches of conflict analysis.

Code: A. c. Knowledge on the approaches of non-violent means of conflict resolution

Absence of knowledge can create confusion that will play an important role to divert an individual to do some non-desirable behaviour.

If an individual is willing to perform for creation of any type of conflicts; through critical analysis of said fact, one must be able to find out some complicated needs of said individual that can play an unexpected motive in that individual. Presence of ideology in the basic structure of individual personality pattern must be helpful for mankind.

Code: A. g. Knowledge to develop awareness about cultural heritage

The facts related to the every corner of human life that practically realized by every member of a society which has developed a basic pattern of philosophy of life in different forms that is considered as the culture. Code: B. a. Skills to generate alternative solutions of conflict

The study of peace education through empirical approach will produce a lot of skills to cope with the problems associated with the alternative solutions of conflict. To manage the non-desirable conflicts with the help of effective creation of alternative solutions, the practice of peace education will be important beneficiaries.

Code: B. b. Skills to deal with emotions

Individual emotions play an important role to regulate individual efforts or behaviour; human emotions have the probability to enrich as well as to destroy the basics of a system. Critical understanding of core concept with the approach of empirical practice of thoughts found from the study

of peace education, an individual will be able to live positively, effectively and efficiently by developing a higher level of adaptability in changing atmosphere. Peace education will produce skills to live with change properly.

Code: B. d. Skills of Communication (active listening, self-expression)

Code: B. f. Skills to cooperate

Code: B. g. Skills of critical thinking

Through the critical thinking, an individual will be able to describe facts in detail form; that is more important to describe any situation responsible to create conflicts within the society. Effective exercises of critical thinking help an individual to utilize probable human resources effectively as well as efficiently. Practice of peace education will stimulate an individual to nurture own efforts to gain a specific pattern of thinking in favour of detail concept formation regarding the reality or corresponding facts.

Code: B. h. Skills of Problem-solving

Skills of problem solving are an important approach to develop a better balanced and a specific personality pattern in favour of the holistic individual development. Through the effective practice of said skills, an individual will be able to manage any problems related to the conflicting agenda. Practice of peace education will stimulate an individual effort in favour of the effective formation of said skills for the benefit of humanity.

After proper analysis of the corresponding skills related code attached with the basic pattern of peace education, it has been specifically observed that peace education has the probability to develop some valuable skills to cope with the conflicting situation within the society. Through the development of positive skills regarding the conflict management with the help of effective practice of peace education, a society will be able to reshape own pattern in favour of the humanity. After analysis of the facts associated with the skill based segment associated with the peace education, attitudinal segment has been analyzed below. Attitude is an important aspects of human personality that basically represents the belief system in respect to the practical approach in connection with own knowledge as well as behavioural reflection and corresponding patterns. In this segment based analysis, attitude built with the practice of peace education has been analyzed.

Code: C. a. Attitude on empathy

Code: C. b. Attitude of self-concept

Concept regarding positive as well as negative aspects of an individual understanding is known as self-concept. Code: C. c. Attitude of tolerance

Through the efficient practice of peace education, this global target will be fulfilled in a satisfactory level. Gender bias is a stimulating factor of conflicts that can be minimized through effective implementation of the principles of equity. Though the effective practice of peace education, an effective attitudinal pattern of an individual will be shape to maintain gender equity that more desirable to cope with the unnecessary influences of conflicts.

Code: C. f. Attitude on the Joy in living

Attitude on the joy of living is an indicator of positivity of human existence for the effective manifestation of human potentiality. It is a positive approach to develop individual will power with the aspiration of creation for own as well as for other with enthusiastic manner. Through the positive exercises of peace education, an individual will be able to shape own life style in favour of the all-round development of individual essence.

So, after analysis, it has been observed that practice of peace education will play an important role to regulate the process of attitudinal monitoring in favour of the benefit of individual as well as human society. To manage the conflicts, effective nurturing of the principles of peace education will be considered as fundamental appropriately.

4.2. Analysis of Code on Social Sustainability:

Sustainable development in respect to the social parameter is known as social sustainability; it is an approach to assure the needs of coming future generations without compromising the needs of present. Society is a universal system of human civilization; it is important to protect the actual essence of basic social systems which are either directly or indirectly related to the hope of human being. In this segment of present study, code related to the social sustainability has been analyzed properly to design a system of society of coming future. In the case of analysis of code related to the social sustainable development, three fundamental segments have been considered to study critically to conceptualise the actual pattern of social sustainability. Code -3 Socio-cultural Segment

There are two fundamental aspects related to the issues of socio-cultural considerations of the sustainable society namely supporting approach and empowering approach. How a future society will be developed or improved properly with the help of some effective assistive parameters that will be available in coming future by effective monitoring of present society and the behaviour socialized members. Empowering approach will also be important to enrich the present status of social activities as well as future society.

5.0.Interpret and Conclusion:

Through the appropriate empirical nurture of the principles and policies of peace education some fundamental skills will be acquired by modern people for the ultimate benefit of coming society namely skills to generate alternative solutions of conflict, skills to deal with emotions, skills to live with change, skills of communication (active listening, self-expression), skills to assertive, skills to cooperate, skills of critical thinking, and skills of problemsolving respectively. Development of these skills, modern society will be able to monitor present social activities by assuring the goals of future. Through the effective exercises of peace education, future society will be able to develop some positive attitudinal values that will be beneficiaries for the coming future society. Those attitudinal aspects are attitude on empathy, attitude of self-concept, attitude of tolerance, attitude to respect others, attitude to gender equity, and attitude on the joy in living etc. Through the development of some valuable understanding, skills and attitude, a society will enable to set a sustainable social structure, physical structure, community structure, opportunities for decision making, contact between neighbours, local control confident, social systems, cultural systems, supporting approach and empowering

approach respectively. At the end of the study, the investigator has concluded that effective study of peace education and its effective implementation in the society and effective inculcation of its basic policies will help to design an effective present society as well as coming sustainable society. Therefore, it is concluded that peace education as a social sustainable development.
