

INTRODUCTION

Following these words of Albert Einstein, it is an obvious possibility being curious about that "bagpipe" and how are all these things determined. Often we look up at the sky and become fascinated by the intellect of the entity that designed the entire universe with all its components. The design of the universe is quite intriguing and it persuades us to know more about our Creator. I would like to begin with the fact that Science doesn't reject the presence of GOD but it rejects its different religional "forms". The universes and all its components (including the multiverses) have several components in it which act as the source of energy and heat. Consider our universe, there are probably a billion if not million and trillion stars present which are coming to existence or dying each day. These events correspond to a large amount of energy. According to the first law of thermodynamics "Energy is neither created nor destroyed" and all these energy balance each other somehow to keep the universe balanced. Now the question arises as to what is the source of this energy? Wherefrom did they come into existence? Were they created from nothing or The Big Bang was the sole reason of their popping into existence in the fabric of "reality"? The answers to these questions may be controversial but a possible solution can be reached. What if these all energy we observe came from something, some entity, not only in case of ours but also for the other universes as well. What if there is an entity (one for now at least) which is solely devoted for the balancing of these universes. Well now that we have this concept of entity roughly, we can conclude that it may be the source or origin of that energy we encounter as well as those which we do not.

THE UNKNOWN ENTITY:

The question to those above mentioned what ifs lay here in this segment. We need to model and analyze the conditions we have. Firstly we consider the region outside our universe where all the other universes as well as our entity lie as within a box. Now we have these universes discretely and randomly lying or rather floating in this box with the entity at one end of the box. The other end of the box is for the time being empty. The amount or the volume of emptiness has the same dimensions as that of our GOD entity reason of which will be revealed later. Now our god entity is purely energy which violates the energy-mass equivalence (reason for which is unknown) for some instant while it remains valid for other instances. We know by planck's law of quantisation of energy E=ph ν_n , where p=0,1,2,3,... and ν_n is the frequency of all the universes energy associated .We will calculate the average energy of the entity over two wavelengths one, which just crosses the maximum observable wavelength of radio waves to infinite and second from the minimum observavle wavelength(i.e gamma rays) to infinite. The reasons for considering infinite wavelength and beyond the percievable range is due to the fact we do not know precisely the wavelength ranges beyond the given ranges of gamma rays to radio waves. Thus it can be concluded that the energy of the god entity remains constant in magnitude (although infinite) yet the sign is different which raises a peculiar question about the negative energy. According to Einstein's mass energy equivalence $E=mc^2$ we can determine the mass but that would be rather incomprehensible when we already know about the relativistic attitude of physics.
