# COVID19 AND LOCKDOWN: PERCEPTION OF INDIVIDUALS TOWARDS POLICE PERSONNEL IN THIS PANDEMIC

Whenever a mistake is made, it will be stopped, and the offender will be punished, and justice will be done to the victim. As time went on, the respect of the people towards the police department increased. However, in today's society, the police department is feared and angered by a few people. This is because people embrace and hate the guards for the mistakes made by a few guards, including the guards who behave well and honestly. The reason for conducting this research is to find out what people think about policing in today's epidemic environment and a consistent explanation for it. This study was conducted among 300 individuals comprising both the genders of Udangudi-Thoothukudi district, Tamilnadu. The questionnaire method was used to collect the response from the individuals, and there were 13 questions, including general information, which the investigator designed. A 'Simple Random Sampling Technique was used to collect the samples, and the research design was employed in this study was a quantitative approach to descriptive design. In examining the information obtained, the people have a reasonable opinion of the police department in this context; they are well aware of the difficulties faced by the police officers and have some expectations among the people.

### I. INTRODUCTION

In India, the modern and professional bureaucracy of police was created by the Indian Council act, which was introduced by the British Government in 1861 and introduced a new cadre of police called Superior Police Service. After India's independence, the legal framework was utterly changed, and under the Indian Constitution Article 312 (2) in part XIV, the modern Indian Poice Service was created [1]. Since then, the police force has undergone much development and is considered the basic tribunal for resolving the people's grievances by gaining good faith among the people. Police officers are beneficial not only in India but also in other parts of the world. One of the surveys conducted last year reported that the police force in India was in a struggle and that the Indian police force was losing strength in the world police force. In the same report, they mentioned that Delhi, Kerala, and Maharashtra are the best police states, and Uttar Pradesh, Bihar, and Chhattisgarh are the weakest police states in India [2]. It has become a typical situation for charges to come against the police department in general. This applies not only to our country but also abroad. In such a situation, they conduct surveys among the people about the police officers in the countries and record the people's opinions on the police officers. The people put forward various complaints about how the police treat those who violated the government rules. This study aims to find out the perception of college students towards police, find the awareness about the policing work among college students, and know the problems faced by the public in this pandemic situation by the police officers.

# II. METHODOLOGY

For this study, the individuals of Udangudi-Thoothukudi district in Tamilnadu were taken as the universe, and the investigator has selected randomly 300 individuals from the community comprised of both genders in the district. The sample is selected through the "Simple Random Sampling Technique." The age of the respondents is distributed from 20-40 years and categorized into four groups, i.e., 20-25, 26-30, 31-35, and 36-40. The research design is a quantitative approach to descriptive design structure within the research study is undertaken. In this pandemic situation, the samples were collected from the individuals very safely, and precautionary measures were taken before and after collecting samples. The questionnaire method was used to collect the response from the individuals of the Udangudi-Thoothukudi district, Tamilnadu. There were 13 questions, including general information which was designed by the investigator covering the awareness about the police work, problems faced by the public during this pandemic, problems faced by the police officers during this pandemic, opinion about police officers, and attitudes of police towards the public. First, the respondents were briefed about the aim of this research, and consent was obtained. The self-made questionnaire was administered to them, and the instructions to the participants were given in filling out the same. The questions were asked in English, so we explained them clearly in Tamil to those who did not understand English and got a response from them. For analysis and interpretation, data was organized into tables, charts, and graphs based on the objectives of the study. Data extracted from the survey responses were entered into Microsoft Excel 2010 software for statistical analysis. The data was converted into a frequency table, and the final results were given in the form of a bar graph and pie chart.

# 3.1General Information








Figure 1. Number of respondents collected according to age

3.2 Awareness about the police department




Figure 3. Level of awareness about the police department among individual

#### 3.3.1 Following government guidelines in this pandemic




Figure 4. Following rules and regulation in this pandemic

## 3.3.2 Punishment for violating rules





Figure 5. Punishment for violating rules

In this pandemic, some people can't follow the government rules and regulations due to their job, working conditions, etc. When they are violating the rules, they must face the consequences and punishments. Figure 5 represents the punishments usually given by the police officers during this pandemic when they violate the rules. 32% of people said that the most common punishment given by the police is an immediate fine and 31% of people said that sometimes they forgive and send us without a fine or any other punishment.




Figure 8. Difficulties faced by police officers




Figure 9. The behavior of police officers in this pandemic




Figure 10. Being strict is correct or not





Figure 11. Police leave their family and work tirelessly




Figure 13. The expectation of the public towards police
