3.1 ARCHITECTURAL DIAGRAM

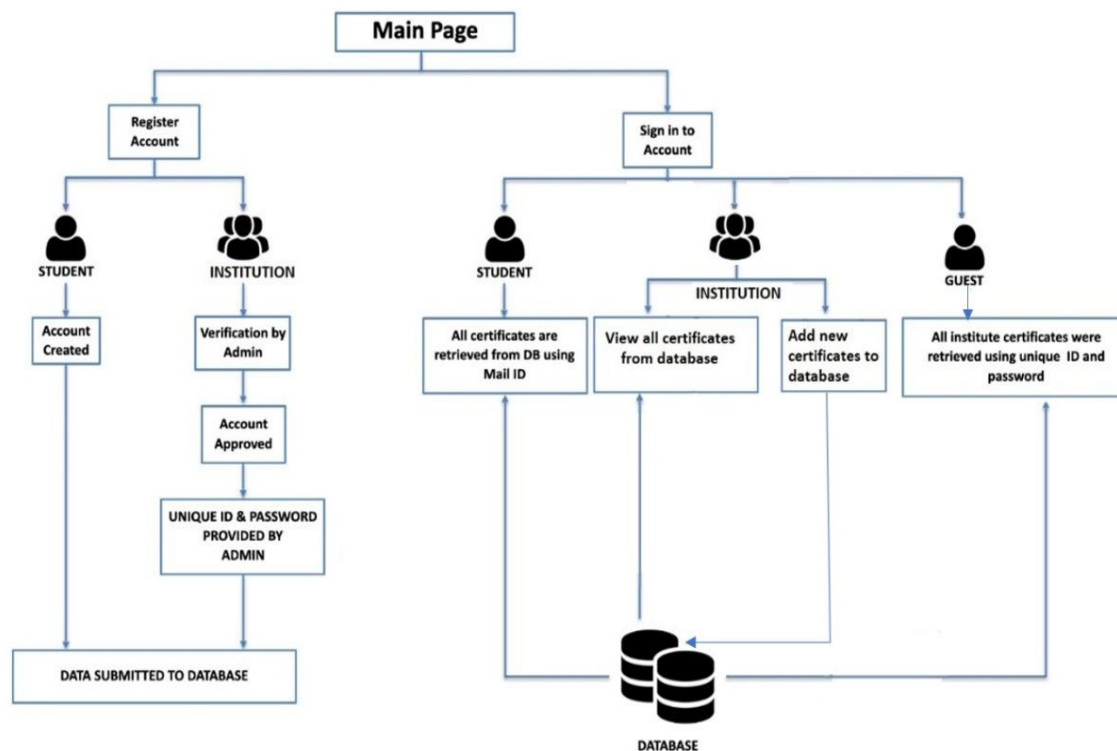


fig 1: website architecture

DJANGO:-

When you run the server, it considers your system as a host. Django develops web applications using the MVT (Model View Template) design architecture. When you create an app with the basic skeleton, the Django administration site is automatically created. Django aims to assist you in developing software that is complete, versatile, secure, scalable, maintainable and portable.

PYTHON:-

Python is an Object-Oriented and Procedure-Oriented Interpreter language, which means it can be used to focus on data objects as well as functions (reusable code). It is the most popular programming language among developers because it is free and portable, and it also supports GUI. It is widely used because it is simple to understand and read. Python is a dynamically typed language, which means that defining the type of variable is not required while writing the code.

SQLITE:-

SQLite is a free and open-source database that aids in the interaction with relational databases. SQLite is a portable database resource. - 8) Create functions in views.py to process data for each request sent.
- 9) The URL requests in urls.py are routed to the functions in views.py
- 10) Perform Migrations on the project, to save all the changes done to the database.
- 11) To start the server, enter this command in the terminal.
`python manage.py runserver`

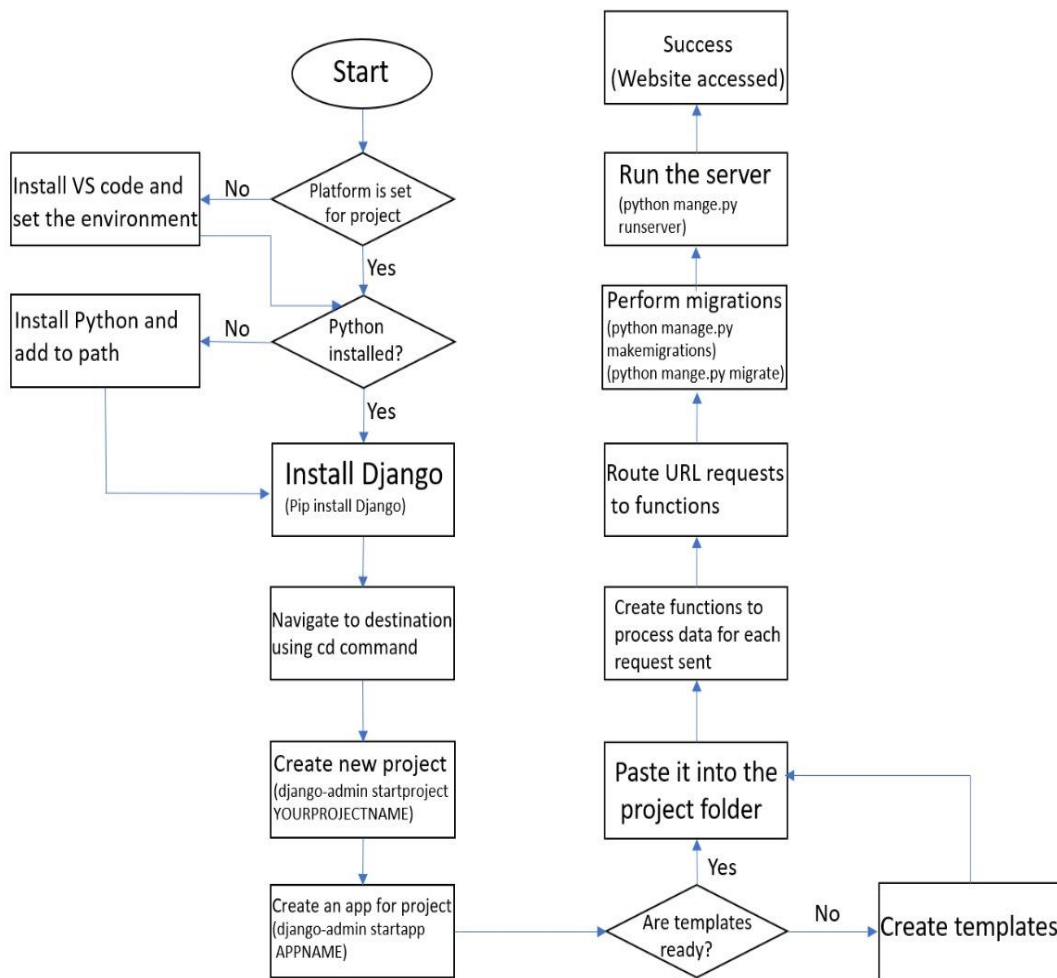


fig 2: procedure of the project

3.4 PROJECT REQUIREMENTS

The following features are required to complete this website.

1. Student Registration :

To create an account on this website, students must first register by entering their full name, email address, and creating a password. When all of these details have been gathered, the student account will be approved.

2. Institution Registration :

The process for creating an institution account differs slightly from that for students. The account handler from the institution is required to provide the following information such as the name of the institution, city, country, email address, password creation, and so on. The account will only be accepted when the admin has personally confirmed that the information provided is accurate (only one account is possible for one institution). The admin will then supply the institution with a unique ID and password.

3. Institution Login :

All of the certificates that the institution has submitted will be accessible anytime they enter into their account. These certifications are available for them to examine and modify. They can also upload new certificates. When uploading new certificates, they must supply basic information such as certificate name, student name, student mail, date, and certificate picture. The student mail ID in this instance is utilized to identify their certificates and enable accessing it through their account. The date they have provided will be utilized to filter out those certificates.

4. Student Login :

The student's email address was used to store all the certificates along with some additional information. As a result, if a specific student wants to get his or her certificates, they must log into their account. All certificates supplied to that student with their mail ID (regardless of the institution) will then be displayed there. To protect their privacy, we provide them the option to conceal or reveal their certificates. Even if the institution uploads a student's certificate, the student has the option to make it visible or hide it from the guest's view. Apart from this operation, the student has no authority to perform any other operations on the certificates.

5. Guest Login :

After their account is approved, each institution is given a unique ID and password, with which an individual can login as a visitor and view all of the achievements of that institute's students. Additionally, visitors can also filter the certificates according to their preferences (by student name, student mail, and range of dates). This allows them to easily analyze the students' engagement in the academic outcomes of that institution.

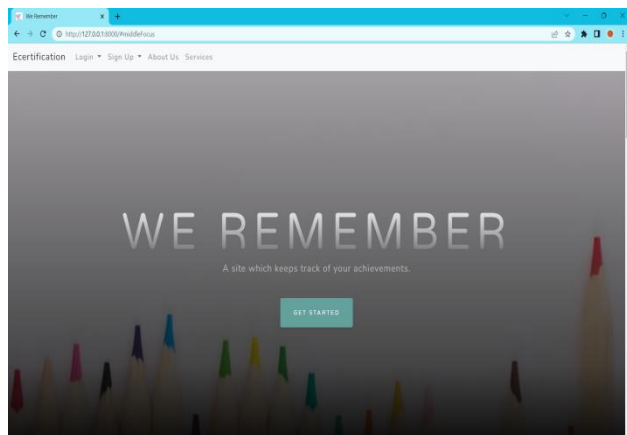


fig 3: main page

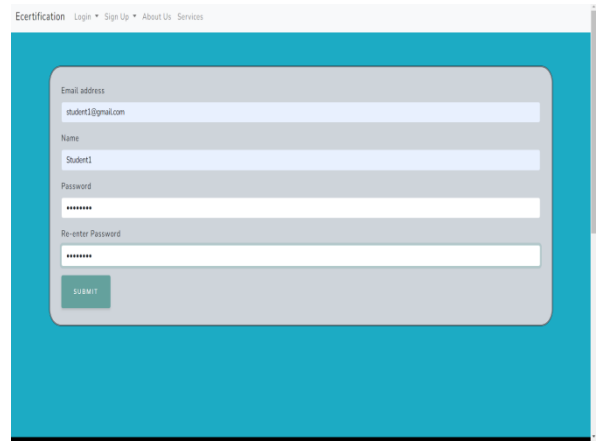


fig 4: student sign up



fig 5: institution sign-up

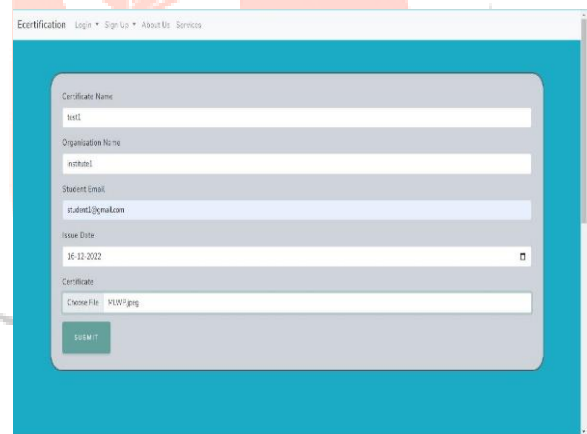


fig 6: adding certificates

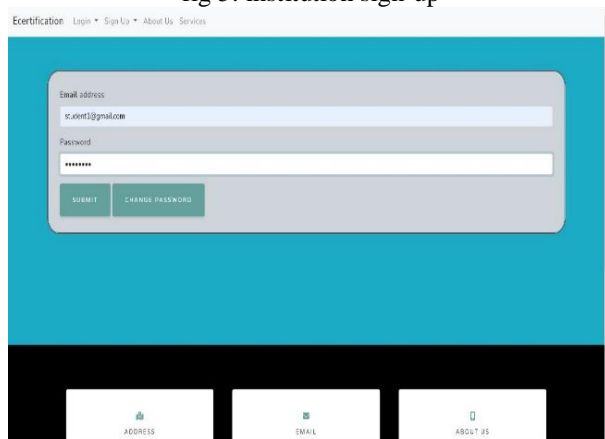


fig 7: student login

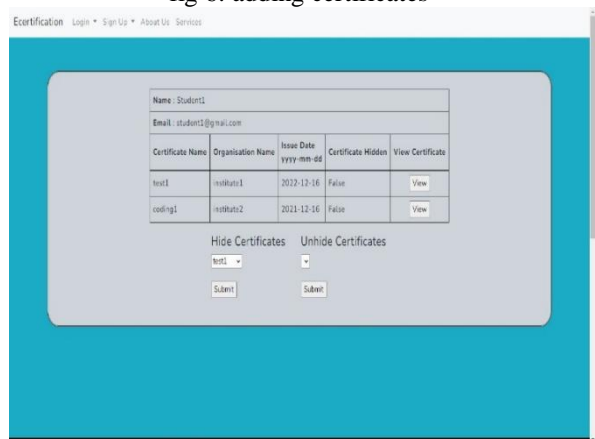


fig 8: certificates in the student account

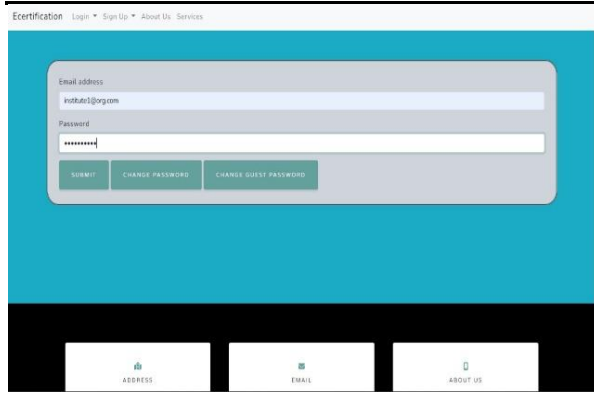


fig 9: institution login

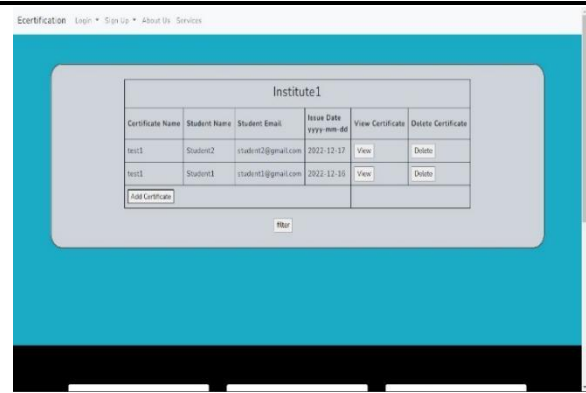


fig 10: certificates in institution account

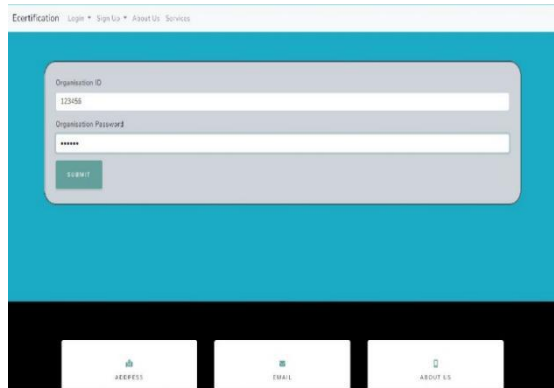


fig 11: guest login

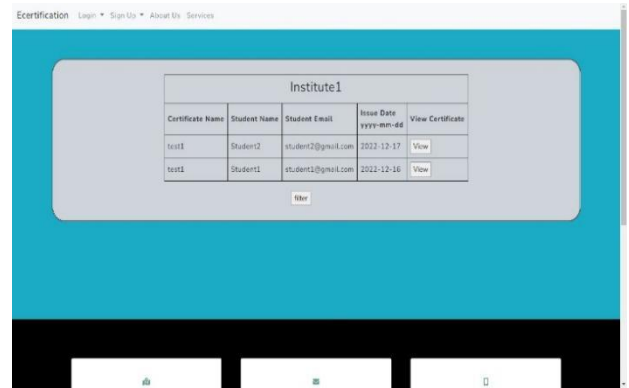


fig 12: certificates in the guest login
