#### 2. Women Empowerment and Challenges:

She can go only out (for sake of visiting and showing her presence. She has to be within the premises of indoor. But, at the same time she has do all the activities of house-hold and house management". Further, since she is a Deity, the perception of man does nt permit to recognize as her indoor activities and labour as work to be paid because it becomes against the family Honour as: how men

can pay to Deity? because men during worship begs everything from the Deity. These two unfortunate perceptions as: Deity and Family Honour, along with the soft nature of women prohibited them in the family to access the basic aspects of logical aspect of life on this planet in form of know-how as: qualification, training, education, jobs, self-employment and so on and surfaces in form of gender-gap and disparity in the middle class towards the women. Further, along with the unfortunate interpretation of the philosophical concept about women as "Women as a Deity" and fixing the unscientific too much emphasis to women as "Family Honour", inherently created "Fear Psychosis" in the minds of the men to whom the women belong. Hence, in the social aspect, these three factors are the culprit for progress among the women of the middle which constitute the backbone of the social fabric altogether.

#### 3. The Conceptual Framework of Women Empowerment:




Figure 1: Block diagram of Sustainable Development
