The scheme is devised to help students against the disturbances created by the pandemic. The government is trying to help school students of 1 to 8th standard with the motive of door step learning.
- ❖ The government is actively appointing volunteers to serve the purpose. Students of government schools can visit nearby illam thedi kalvi centre and get admitted voluntarily or with the help of teachers who will guide them in enrollment. Classes will be conducted at a common place or volunteer's house after school hours, and this will continue for only six months. The government has allotted ₹200 crore for the implementation of the scheme. More than 1 lakh volunteers play a vital role in encouraging parents to send their children to school.

llam Thedi Kalvi Scheme Objectives

- To fulfill the learning gap with the doorstep learning in order to compensate for the losses during the pandemic and closures of schools.
- **!** Enrollment of one lakh students from the state with the government schools.
- ❖ The government will appoint volunteers through the school management committees which consist of 20 members.

- ❖ The Scheme has been evolved in accordance with the inputs given by UNESCO alongwith Economic Advisory Council of State Government and educationists,.
- The volunteers will reach students in order to improve the condition of education, motivate parents to continue their children's education, work for the development of the local school.

Illam Thedi Kalvi Scheme Eligibility

- ❖ School students of Tamil Nadu who are enrolled with government schools.
- ❖ Interested candidates can become volunteers by producing their experience, place of birth and educational qualifications in front of school management committees.
- Online exam and following that Two days training is mandatory to become volunteer.

Major Findings of the study

❖ All the respondents (100%) are Female. It shows that Female volunteers are more in tamilnadu than men reason could be stated as their work nature, house wife ext..

- ❖ More than Half of the respondents (57%) belonged to 26- 35 years of Age group. In this age group women are studying and preparing for various government exams.
- More than Half of the respondents (63%) are Degree holders.
- Majority of the respondents (73%) are in town.
- Nearly Half of the 53% of the respondents have 16-20 children in the centre. Rest of them had difficulties in enrolling the students.
- Most of the respondents (73%) access online attendance. It shows that one fourth of the respondents have not marked attendance through Illam Thedi Kalvi App. Hence, awareness needed to receive the incentives from the government without any delay.
- Most of the respondents (97%)like to be flexible in the class because it is one of the rule that physical punishments are forbidden.
- ❖ Incentive is not a challenge for 77% of the respondents. Volunteers are clear about their role and expectation about incentive is less among them.
- Majority of the respondents (83%) receives support from the centre heads like Arrangement of ID card, Information about Exhibition for volunteers and distribution of teaching materials
- Majority of the respondents (87%) stated that Parents involvement is high.
- Majority of the respondents (83%) responded teachers involvement is sufficient.
- ***** More than Half of the respondents (77%) stated that society has awareness about this scheme.
- The scheme is implemented effectively by volunteers. *
- High level of participation is found during the study.

Conclusion

All the respondents understand the scheme's objective and works accordingly. If the scheme is extended even after the project period of six months, it would be more useful for the poor children those who cannot afford tuition fee privately. The scheme would give the way for a holistic development of children. Association of teachers, parents, volunteers in implementing the scheme is necessary to achieve the objective of making children fully developed citizens.
