It was a residential school system dating back to about 5000 BC, where shishya (student) and guru (teacher) used to reside in the guru's ashram (home) or in close proximity (Fran 2023).

Gurukul was known for its unique teaching methodology. Here, the teaching model is deliberately designed to make learning much more interesting, so that the legacy of classical music reaches the world with its values. This method and all the activities performed by the guruku made classical music attractive to the younger generations. Students receive music not only through live sessions, but also through the environment in which they live. A complete understanding of music is possible through reading, listening and visualizing to gain a broader perspective on music so that you can develop your creativity and step forward. more innovative concepts. Guru-shishya Parampara is also ancient and also known as the best system of concentrated learning. Since Vedic times, the guru imparted musical training orally. This is called guru-mukhi vidya. The best way to gain proper knowledge of any lore is to understand it through guru-mukhi. Living in a Gurukula, a student renders services to the Guru by living under strict discipline, following a moderate lifestyle and constantly practicing and learning whatever the Guru gives. It was the only way to get a musical education.

The 'Gurukul' system of education was replaced by the Modern School system bought in India in 1830 by the lord Thomas Bobington Macaulay. This system introduced classroom learning where the linked with nature as well as the close emotional bond between the teacher and the student was broken.

The main goals of Gurukul were self-control education, character development, sociability or social awareness generation, integral development of personality, purity propagation, and knowledge and culture preservation. Unfortunately, the Gurukul concept has vanished, and Lord Macauley introduced the modern educational system to India in 1835. Subject music was introduced in various institutions such as Banaras Hindu University, Mumbai University, Visva Bharati University Santiniketan, MS University Vadodara, Bhatkhande Sangeet Samsthan Lucknow, Punjabi University, Patiala etc.

In the Modern period, our society has the scattered Gurukulas, not like a big one of classical era. Perhaps, the socio-economical scarcity is the cause of that. It should be mentioned that the ancient Gurus didn't charge any fees or any extra-advantage for their teaching, but from the later period, there are the institutions which have the beneficiary target to gain more and more profit, like a business, to admit the less quality students also. Exceptions are always side by side of any system, here it is too.

Today, it is necessary to ensure that there is a friendly and mutually respectful relationship between teachers and students. Children who feel safe and trust the caregiver are most likely to imitate the caregiver. It existed in the gurukula system. Today, the same can be achieved by connecting with students through activities and workshops.
