

Narcotic drugs induce sleep, whereas psychotropic drugs affect the mind and alter people's mental abilities. The NDPS Act was enacted by India's parliament on November 14, 1985. Its goal or purpose is to keep drugs of abuse under control by prohibiting their use, dissipation, distribution, manufacturing, and trade, among other things. (1) This act was introduced in the Lok Sabha on August 23, 1985, and was passed by both houses of parliament. It then got presidential assent on September 16, 1985, and went into effect on November 14, 1985. It was revised thrice in 1988, 2001, and 2014. (2). There are a lot of drug addicts in our culture. Substance misuse causes a slew of challenges, including health issues such as mortality and psychiatric illnesses, as well as economic issues such as money spent on developing services, a drain on national resources, and a loss of productivity. It also causes a slew of societal issues, such as family dissolution, which can lead to criminal activity. More delicate concerns have arisen as a result of the drug war than any other occurrence in our history. It could be the source of crimes ranging from white-collar to blue-collar. In an era of terrorism, where drugs are a means of generating cash for terrorist activities, this is a critical topic that should be considered when drafting and updating drug legislation [3].

The study was a prospective observational study. It was conducted between date 12 JAN **2024 to 12** FEB **2024.** A self-made Questionnaire was designed. SURVEY AND IT'S BAR GRAPH


PARTICIPANTS RELATED INFORMATION [Table 1-3]:-


Count of Age of the participant




TABLE 3:- OCCUPATION OF THE PARTICIPANT:















RESULTS AND DISCUSSION :-

Among 504 Participants, Majority of people had no proper awareness regarding Narcotic drugs and Psychotropic substances and its abuses and about its harmful effect. People are not aware about how to manufacture, stock, transport and distribute ND/PS with valid permission. Most of the people do not possess the knowledge about the existing laws on ND/PS. Some of people feel that for stress suppression consuming drugs is an easy and convenient path but are not aware of the repercussions.

CONCLUSION:-

Total 504 Participants Participate in this survey. Drugs is a substance prescribed by doctor. In some cases its harmful (due to its overdose effect and adverse effect) and addictive substance like in case of narcotics drugs and psychotropic substances. Second, narcotic drugs induce addiction, whereas psychotropic substances affect the mind and alter people's mental abilities. Certain harmful effects of drugs are addiction, memory loss, heart damage, lung problem, anxiety etc. Manufacturing, stocking, distribution and consumption of narcotic drugs and psychotropic substances without appropriate permission is illegal.

The participants had a rudimentary knowledge of the term drug. However, most of the participants had not encountered the term narcotic drug or psychotropic substance. The participants knew that manufacturing, stocking, transportation and distribution of drugs is illegal however, the legal punishments were not known to them. Most of the people were not aware of the fact that the Covid-19 pandemic led to increased abuse of drugs among the people due to incurrence of financial losses and resulting mental stress. A significant number of the participants were not aware of the small and commercial quantities of drugs in the context of drug law enforcement/trafficking and abuse. A significant portion of the participants was not aware that consuming drugs for stress suppression is inappropriate. It was also found that the participants had little knowledge about synthetic drugs which are now increasingly being pushed in the drug market as low-cost alternatives to the conventional narcotic drugs. A majority of people didn't how exactly they should deal when they come to know of a friend or close acquaintance consuming drugs. The participants expressed that organizing awareness camps on large scale at regular time intervals would reduce drug abuse cases among the youth.
